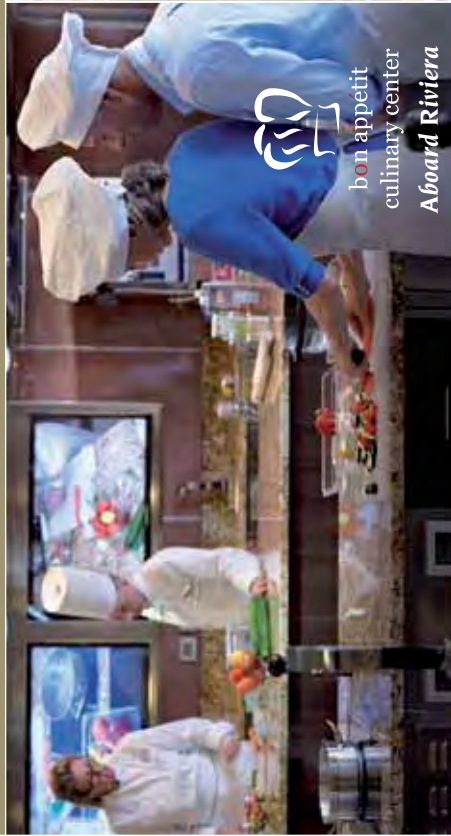

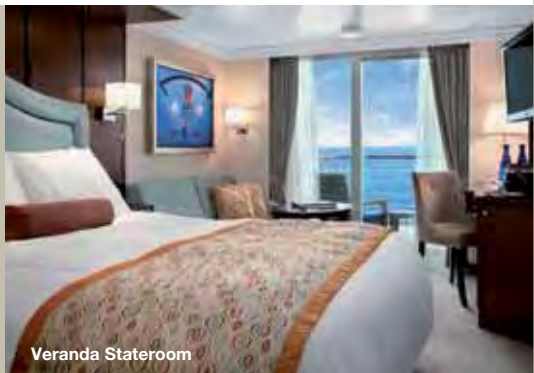

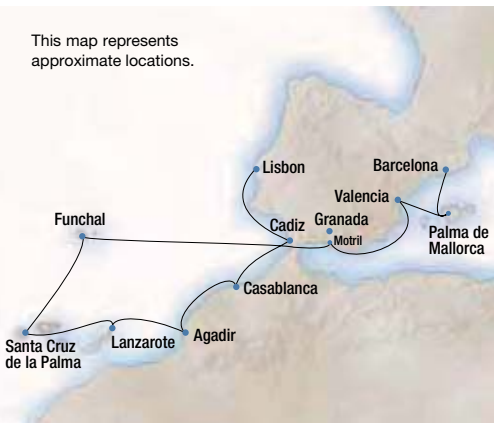

PORTS OF CALL

PALMA DE MALLORCA, SPAIN Explore this beautiful island, beginning with the magnificent Palma Cathedral and Bellver Castle. See the windmills and an 18th-century manor house in the verdant countryside. Discover the amazing natural wonders in the Drach Caves. Or visit the former Carthusian Monastery in Valldemosa where George Sand and Chopin spent a winter.
